**AMENDMENT TO SECOND AMENDED AND RESTATED
DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS
FOR PORTILLO RIDGE**

THIS AMENDMENT is made this 5th day of June, 2013, by the owners of the real property described as:

Lots 1 through 143, and Common Areas A, B, and C of Portillo Ridge as shown in the Plat of Record in Book 47, at page 23 of Maps and Plats of the Pima County Recorder's Office.

and is to that certain Second Amended and Restated Declaration of Covenants, Conditions and Restrictions for Portillo Ridge (the "Declaration"), which was recorded in the office of the County Recorder of Pima County, Arizona on May 8, 2006, in Docket 12799 at pages 5396 *et seq.*

ADD AT THE END OF SECTION 5.19 Trash and Recycling:

Trash Collection Services. The Board of Directors of the Association shall engage a single company for trash removal and recycling services. Each household shall use only the single company selected. The Board shall decide and notify the Owners whether each household shall contract with the single company selected and pay directly, or whether the Association will have a single contract with the company selected with the costs included in the Association's assessments. The Board may promulgate rules and regulations governing all matters pertaining to trash removal and recycling services.

IN WITNESS WHEREOF, the undersigned officers of Portillo Ridge Homeowners' Association hereby certify that the foregoing Amendment to the Declaration was
